The concern with pedagogy, teaching and learning at this conference reflects the wide attention being given to such topics in the context of moves towards developing cultures of lifelong learning in different countries around the globe. Providing a stronger research base for our pedagogic practices has become a major concern, one which we believe to be illuminated, empirically, theoretically and methodologically by the papers published here.

The conference's importance is also symbolised the support it has received from the UK's Teaching and Learning Research Programme, Stirling Council, RoutledgeFalmer and the LTSN for Education. We are especially delighted that this conference formed part of the Economic and Social Research Council's (ESRC) Social Science Week 2005.
