Brief profile of the Sino-Australian Joint Research Program

In 2009, the Co-Directors of this new Joint Program - Professor Michael Wesley at Griffith University (GU), Professor Wang Xinsheng at Sun Yatsen University (SYSU), and Professor Don McMillen at the University of Southern Queensland (USQ) - developed this exciting initiative with colleagues at the partner institutions and with others elsewhere. The Joint Program is devoted to research, research training, scholarly exchange, and dialogue.

All parties currently involved in the Joint Program firmly believe that it, and especially the Annual Dialogue Forums, have the potential to be both highly visible and very meaningful "follow-ups" to on-going efforts by the various governments of the two countries designed to enhance their bilateral relations and their relations with other relevant regional and global actors.

While the Joint Program is based at the core partner universities in the PRC and Queensland, its intention is to network and interact with other universities, expert bodies, governmental organisations, relevant IGOs and NGOs, and private sector actors from both countries - and beyond. It intends to devote the focal areas of its research agenda, related activities, and outputs to a range of crucial current and looming issues of concern to *all* parties, "glocally" (see the Notes attached to the Draft 1st Forum Program). In particular, its efforts will be focused on exploring critical issues related to broadly defined sustainability and traditional/non-traditional security. It intends to do this by identifying and involving the best available expertise and most influential thinkers/players.

Briefly, the main components of the Joint Program are: Annual Dialogue Forums (from July 2009); A two-way (and possibly broader) Distinguished Visiting Researchers Scheme (from 2009); A Research Studentship and Training Plan (from 2009-2010); Professional/Specialist Short Courses (from 2010); A Publications Program (from 2009-2010); and Undergraduate Student

Exchanges/Study Tours (from 2010).

Beyond the current themes set for the first Annual Dialogue Forum to be held in Guangzhou, other Focal Research Areas in the Joint Program's agenda that likely will be given future in-depth treatment (and will be highlighted in subsequent Annual Dialogue Forums to be convened in Australia and China) are:

- Sustainable business, strategic trade, and glocal economic security
- Glocal population and migration issues: the challenges of identity, cultural sustainability, jurisdiction, and governance 'national' and 'human' security dimensions
- Managing regional security: 'architecture building' and law and order/policing as issues in Sino-Australian relations
- Sustaining humanity: the energy and food security nexus in the Asia-Pacific region
- Technologies and their implications for sustainability and security in the 21st century
