## Instructions for authors

### Submission of Manuscripts

Manuscripts should be submitted to Graeme P. Berlyn, Ph.D., Yale University School of Forestry and Environmental Studies, Greeley Memorial Laboratory, 370 Prospect Street, New Haven, CT 06511, USA. Electronic manuscripts are preferred (.doc or .docx) and should be submitted to [jsf@panlists.yale.edu](mailto:jsf@panlists.yale.edu). All editorial inquiries should be directed to the Editor.

Each manuscript must be accompanied by a cover letter providing the name, affiliation, and contact information for all authors, as well as the contact information (including email address) for THREE potential peer reviewers. The cover letter must also include a statement that the manuscript has not been published elsewhere and that it has not been submitted simultaneously for publication elsewhere. Authors are responsible for obtaining permission to reproduce copyrighted material from other sources and are required to sign an agreement for the transfer of copyright to the publisher. All accepted manuscripts, artwork, and photographs become the property of the publisher.

All parts of the manuscript should be typewritten, double-spaced, with margins of at least one inch on all sides. Number manuscript pages consecutively throughout the paper. Authors should also supply a shortened version of the title suitable for the running head, not exceeding 50

character spaces. Each article should be summarized in an abstract of not more than 100 words. Avoid abbreviations, diagrams, and reference to the text in the abstract.

### References

References, citations, and general style of manuscripts should be prepared in accordance with the APA Publication Manual, 4th ed. Cite in the text by author and date (Smith, 1983) and include an alphabetical list at the end of the article.

Examples:

*Journal*: Tsai, M., & Wagner, N. N. (1978). Therapy groups for women sexually molested as children. *Archives of Sexual Behaviour*, 7(6), 417-427.

*Book*: Millman, M. (1980). *Such a pretty face*. New York: W. W. Norton.

*Contribution to a Book*: Hartley, J. T., & Walsh, D. A. (1980). Contemporary issues in adult development of learning. In L. W. Poon (ed.), *Ageing in the 1980s* (pp. 239-252). Washington, DC: American Psychological Association.

### Illustrations

Illustrations submitted (line drawings, halftones, photos, photomicrographs, etc.) should be clean originals or digital files. Digital files are recommended for highest quality reproduction and should follow these guidelines:

- 300 dpi or higher
- Sized to fit on journal page
- EPS, TIFF, or PSD format only
- Submitted as separate files, not embedded in text files

### Color Illustrations

Color art will be reproduced in color in the online publication at no additional cost to the author. Color illustrations will also be considered for print publication; however, the author will be required to bear the full cost involved in color art reproduction. Please note that color reprints can only be ordered if print reproduction costs are paid. Print Rates: \$900 for the first page of color; \$450 per page for the next three pages of color. A custom quote will be provided for articles with more than four pages of color. Art not supplied at a minimum of 300 dpi will not be considered for print.

### Tables and Figures

Tables and figures (illustrations) should not be embedded in the text, but should be included as separate sheets or files. A short descriptive title should appear above each table with a clear legend and any footnotes suitably identified below. All units must be included. Figures should be completely labeled, taking into account necessary size reduction. Captions should be typed, double-spaced, on a separate sheet.

### Proofs

Page proofs are sent to the designated author using Taylor & Francis' Central Article Tracking System (CATS). They must be carefully checked and returned within 48 hours of receipt.

### Reprints and Issues

Each contributor will be granted complimentary e-access to their article, with the ability to download it in PDF format, provided the contributor has submitted an email address to the publisher. Contributors will have the opportunity to buy reprints of their article at the proof stage of production.
