Internationally, municipal food and garden organics have long been diverted from landfill to harness their nutrient and energy value. Diversion of food waste from landfill in Australia has only recently begun to be discussed seriously. This research aimed to assess feasibility and benefits of integrated composting and anaerobic digestion processing facilities. The study reviewed key chemical and physical characteristics of the combined municipal waste organic feedstock, and then analysed several different processing options with varying products to determine which provides the optimum economic returns.
