JTLGE publishes the following types of articles from higher education/industry perspectives:

- Research papers (up to 8,000 words) (double blind refereed)
  Exemplary and evidence-based practice (up to 8,000 words) (double blind refereed)
  Review and Commentary (up to 2,000 words) (Editor reviewed)

Contributions are welcome in relation to any aspect of higher education teaching and learning which relates to the broad topic of graduate employability, including but not confined to:

- · Graduate employability and how it can be measured
- The relationship between graduate employability and the achievement of graduate attributes, employability skills and
- Teaching and learning experiences, resources and assessments which enhance graduate employability
- · Industry partnerships and perspectives
- Life-long learning.
- We particularly encourage papers which are partnerships between stakeholders (industry, students and academics). Submissions to date include:

- Accepted
   Conditionally Accepted: minor revisions to be made by the author(s)
   Revise and Resubmit: major revisions needed

### **Publication Frequency**

The Journal of Teaching and Learning for Graduate Employability has a continuous publication system, offering scholars an efficient process with a short turn-around time for accepted submissions.

Each annual edition will open in the first scheduled month with published articles; other successfully reviewed articles will be added during the ensuing months.
